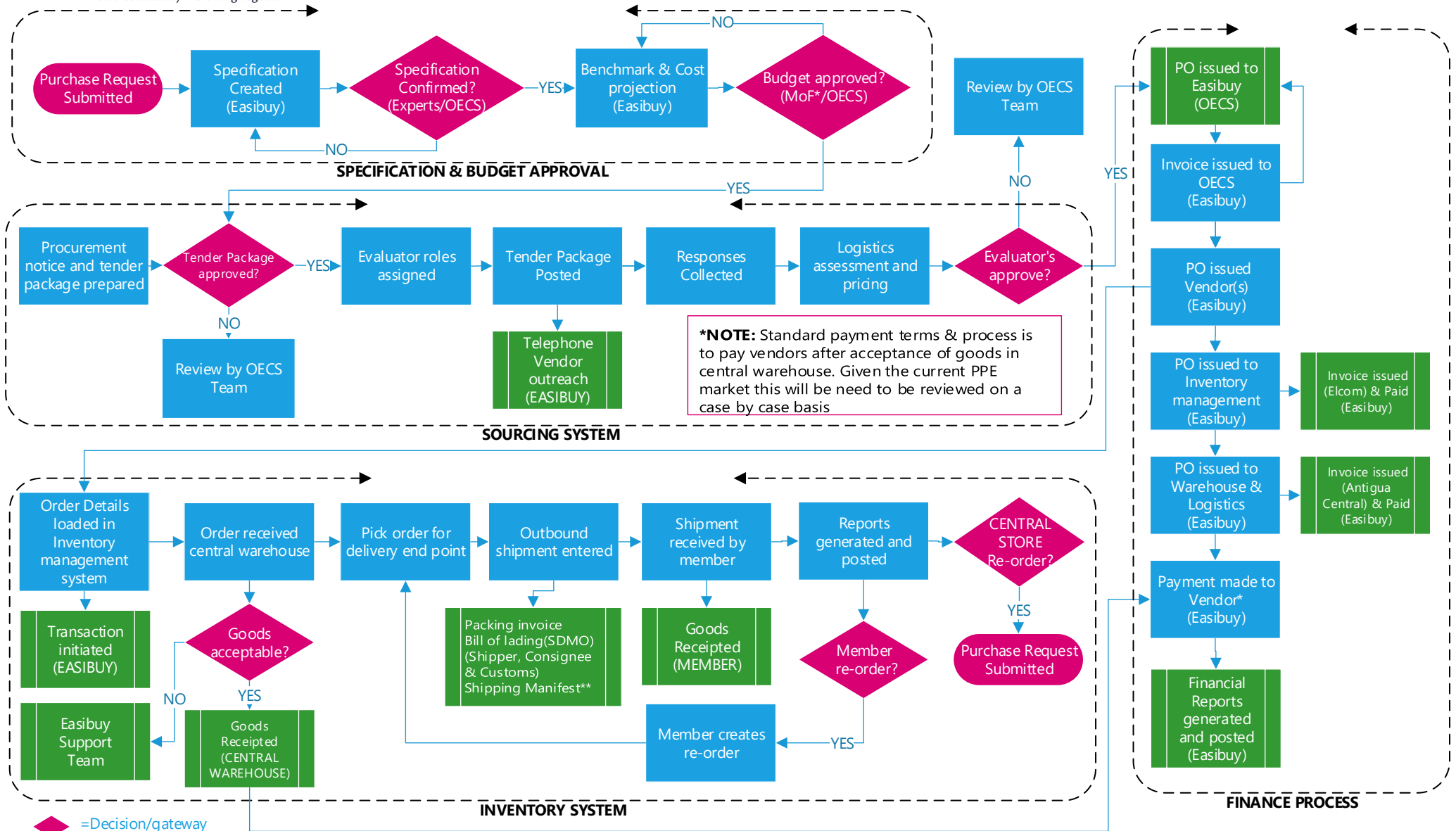


# Procurement and Transparency challenges in the COVID-19 environment

- Smaller countries ordering on their own are at a supreme disadvantage
- Lack of Emergency Procurement Frameworks
- Lack of capacity threatens to overwhelm the regions ability to execute large and rapid response
- Fast acquisition is prioritized over transparency
- Rapid response requirements shine a bright light on inefficiencies and the exorbitant costs of regional shipping resources

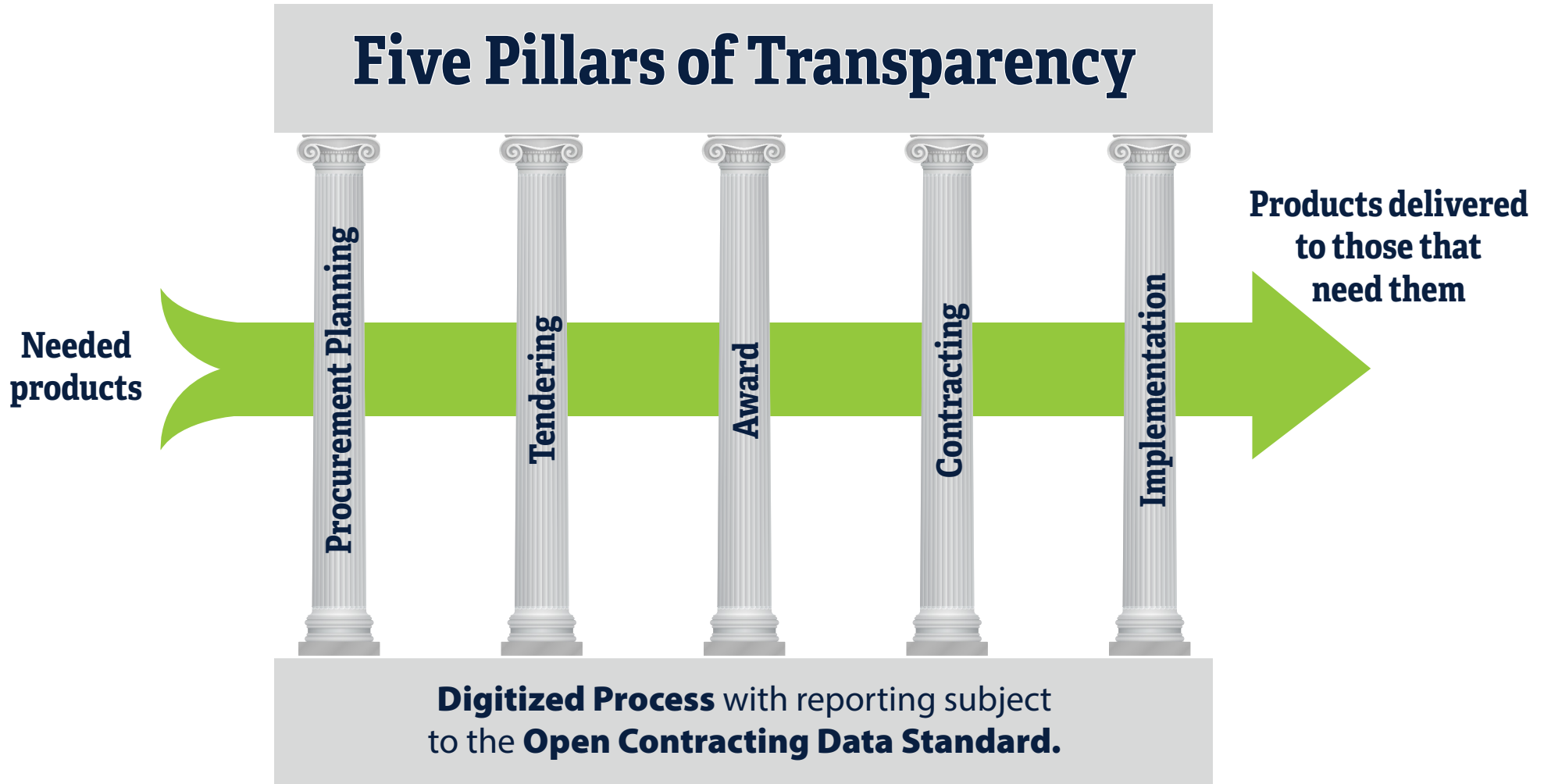

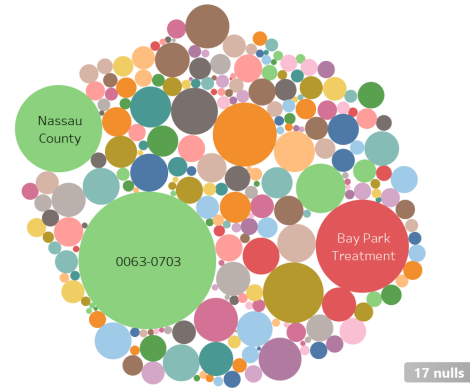

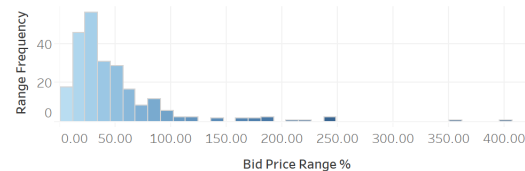


Relative Contract Values

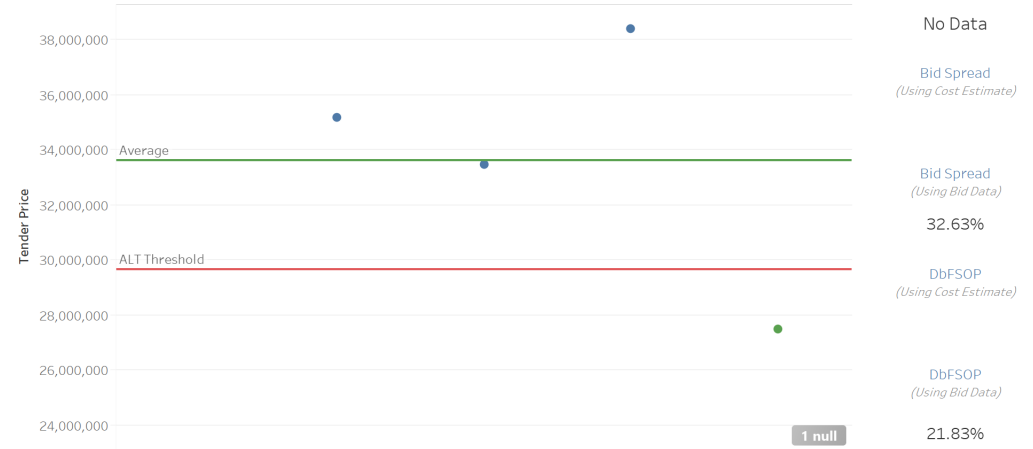
