EXPO INGP 2026 – FIRST EDITION

Connecting the Regional Public Procurement Ecosystem

XX INGP ANNUAL CONFERENCE - August 11-12, 2026.



For the first time, **Expo INGP 2026** will be launched at CINTERMEX¹ as a high-level strategic platform designed to showcase innovative private sector solutions to the challenges of public procurement in the region, with the objective of exploring the connection between governments' public demand and private sector supply, under a public value-oriented approach.

Expo INGP 2026 is designed for companies with demonstrated experience in innovative, technological, and sustainable solutions applicable to public procurement systems across the Americas.

On August 11, 2026, Expo INGP 2026 will be held in conjunction with **PROVEE NL 2026**, the leading government-business procurement matchmaking event in the state of Nuevo León. PROVEE NL convenes public officials, international organizations, business leaders, MSMEs, chambers of commerce, and universities, serving as a dynamic platform for dialogue between private supply and public demand. This alignment will provide exhibiting companies with a first day of enhanced visibility within a broad and specialized ecosystem, while preserving the distinct identity and objectives of each event.

On August 12, the public sessions of the **XX INGP Annual Conference**² will formally commence. Participating companies will have the opportunity to interact with the highest public procurement authorities from more than twenty-five countries, alongside representatives of multilateral organizations and leading experts in procurement modernization.

² [INGP Annual Conference 2026](#): The INGP Annual Conference is the hemisphere's premier forum for dialogue on public procurement, bringing together the highest public procurement authorities alongside representatives from national, provincial, and local governments, academia, experts, civil society, and the private sector. Within this platform, countries share progress, address common challenges, and strengthen regional cooperation frameworks.

In this context, EXPO INGP 2026 represents a unique opportunity to:

- Showcase innovative solutions to leading public procurement authorities across the region.
- Align private sector offerings with real public sector challenges and priorities.
- Generate business opportunities with regional scalability.
- Foster public–private collaboration within the public procurement ecosystem.

Participation will be strictly limited to twenty (20) companies with exhibition stands, selected based on proven experience, the innovative character of their solutions, and their potential for regional impact. An additional five (5) companies may participate under a sponsorship modality, without an exhibition stand.

The Inter-American Network on Government Procurement (INGP) is a mechanism of the Inter-American System aimed at strengthening institutional capacities in public procurement, in order to promote stronger institutions capable of managing more effective procurement systems focused on generating greater public value for citizens, in alignment with national, local, and global contexts. We invite participating companies, within the applicable categories, to incorporate interactive technologies or products into their exhibition space in order to provide attendees with immersive, dynamic, hands-on experience.

Exhibition spaces will be assigned to interested companies upon receipt of proof of payment sent to the email address indicated in this call. The participation fee per category for the Expo does not include travel, accommodation, meals, coordination, transportation, or booth setup costs. All such expenses and related logistics are the sole responsibility of each participating company.

The booths provided will include a basic structure consisting of partition panels between stands, access to electricity, one table, and two chairs. Upon receipt of the expression of interest, additional information will be shared, including the corresponding technical specifications.

Should companies require additional adaptations or complementary equipment, contact information for authorized service providers designated by the organizers will be provided. Any costs associated with these additional services must be covered directly by the requesting company.

The OAS and the other event organizers will not assume responsibility for the coordination, logistics, transportation, assembly, or dismantling of the booths. Likewise, the OAS and the Conference venue will not be liable for any loss, damage, or incidents involving goods, solutions, or materials under the custody of participating companies.

II. TERMS AND CONDITIONS:

- ✓ **Interaction with authorities:** Company representatives may engage with government officials exclusively within the designated EXPO space, ensuring that all interactions are conducted in a transparent, institutional, and respectful manner.
- ✓ **Business Integrity:** Participating companies must not be subject to any ongoing investigations related to potential conflicts of interest, corruption, money laundering, or other illicit activities, nor have they received illegal funds from such sources.
- ✓ **Continuous Ethical Conduct:** Company representatives must always maintain ethical behavior, including refraining from offering personal gifts to any participants or event organizers.

- ✓ **Panel Participation:** For the Diamond category, company representatives participating in the Annual Conference agenda under the Diamond category shall ensure that their interventions are demonstrative, focusing on the benefits of their solutions for strengthening more innovative and/or sustainable public procurement. Presentations must not include misleading, biased, or unverifiable content.
- ✓ **Right to Terminate Participation:** The event organizers reserve the right to terminate the agreement with any company that fails to comply with the established terms, without entitlement to reimbursement of contributions.

Payment:

Upon receipt of the expression of interest, the OAS will issue formal acceptance of participation along with the corresponding bank account details for the transfer of the contribution. The payment must be completed within ten (10) business days from the date of acceptance.

Once the contribution has been made, companies must send proof of payment to the designated SG/OAS email addresses. Participation rights under the selected category will only be granted once the SG/OAS has confirmed receipt of the transferred funds in its bank account.
